Eligibility:

Any business professional residing in Ontario is eligible to be nominated for the Awards of Excellence. In agreeing to be nominated for an Award implies that, in the event of selection as an Award recipient, the individual agrees to participate fully at the event and work with the CIBPA HH in public relations activities for the awards.

Award Categories and Criteria:

- **Business Excellence Award:** This award honours an individual and/or business who demonstrate outstanding achievement in entrepreneurialism, community involvement, high standard to employee relations, sales and/or employment growth, product or market innovation, and significant contribution to the arts, including Italian heritage/culture.
- **Professional Excellence Award:** This award is presented to an individual who through his or her career has consistently demonstrated an outstanding contribution to their field of expertise in setting their goals and attaining their achievements, including community involvement and significant contribution to the arts, including Italian heritage/culture.
